Call to order: The meeting was called to order by President Brookelea Lutton

Announcements: Happy Birthday to Sharon Baker. The Bilby/Stoecker family donated clothing and a history book. **Approval of Minutes:** November 9, 2015--Diane Borden: Minutes of November 9 were approved and submitted.

Treasurer's Report/Bills:--Jeanette Lawson: Treasurer's Report was approved and submitted. SMUD bill \$225.93 approved for payment. Board approved to pay Merry Maids up to \$500 to clean museum/bathrooms. Board approved continual membership in EG Chamber \$100 and \$150 for Luncheon meetings for Brookelea to attend.

Foulks House Restoration and Storage: Jim Entrican – Preparation for the restoration continues

Scout Projects: Jim Entrican – Jim has many projects lined up but need better weather. A spare file cabinet will be set aside for the Rhoades School and will be stored in basement

Big Day of Giving: Dennis Buscher – Profile completed and will be submitted. Four "boot camps" of learning are scheduled after the holidays, which Dennis and Louis will attend. An estimate of volunteer hours is needed and will be added to the profile. Members will provide individual estimates.

New Business:

2016 Informational Displays: Barbara Claire – After the holidays, an informational display about the Sheldon and Daylor families will be setup.

The Sims Ranch and Nicolaus Dairy: Jim Entrican – These are valuable historic properties that will enhance educational opportunities and hands-on agricultural experience for beginning farmers. A partnership of several entities will continue to identify improvements that can be done in the near-term. Jim said there are improvements to the road, tree, and bush trimming, and general cleanup around the adobe house. The Sacramento County Regional Sanitation District Board will prepare preliminary cost estimates and will establish a \$1 million dollar reserve fund for Bufferlands property improvements

The Linda Mae Mahon-Lema Foundation: Dennis Buscher - Guest David Lema was introduced and informed us of a foundation he is starting in his wife's name. He asked for the society's support.

Lewis & Clark Organization: Dennis Buscher – The organization expressed an interest in visiting the Franklin Cemetery next year. Dennis and Jim will coordinating the request.

Tables for sale: Lorraine Croup – An opportunity to purchase round wooden tables for \$20 each was discussed. If they were in good shape, it was approved to spend a maximum of \$200 to purchase them. Note: the tables were subsequently sold to others.
