Approval of Minutes-- August 12, 2013-- Diane Borden, Recording Secretary:

It was moved by Brookelea Lutton and seconded by Sally Bergen to accept the minutes of the August 12, 2013 Board Meeting, which were sent to the Board for review, as submitted. Motion carried.

Treasurer's Report/Bills--Jeanette Lawson, Treasurer:

Jeanette reported that Ed Keema has been fully paid for his expenses in the amount of \$2,500 (out of the Restoration Fund account) for the Time Capsule. In addition, payment was made to Pressley & Assoc. in the amount of \$5,000 (from the grant received from the City).

Jeanette presented bills for approval: To SMUD in the amount of \$224.39 and to Jim Entrican in the amount of \$410.46 to reimburse him for copies (6) made of the architectural plans for Foulks House. It was moved by Milt Webb and seconded by Brookelea Lutton to approve payment. Motion carried.

Jeanette reported that \$143.76 has been received from Raleys cards for the Rhoads School Account.

It was moved by Diane Borden and seconded by Sally Bergen to approve the Treasurer's Report as submitted. Motion carried.

Committee Reports:

Antique & Craft Show—Brookelea Lutton:

Brookelea reported that we have 31 vendors and 1 more application is expected. She has rented a generator for the sound system for \$40. Jeanette will provide the water but may not be able to stay. Brookelea will send a note to those who have committed to help and let

them know when to arrive, but set-up will begin at 6:30 AM. She also passed around a photobook she made of the Tea.

By-laws Update--Dennis Buscher:

Docents—Annaclare Entrican:

In Annaclare's absence, Barbara passed around a sign-up sheet for the Haunted Stage Stop event. Docents should be in costume.

Haunted Stage Stop—Jeanette Lawson:

Jeanette reported that she has received a total of \$5,050 in donations from various family members, friends and other resources, which included some grant funds. The Board approved an additional \$2,500, for a total of \$7,500 available for this event. Expenses so far are approximately \$4,000. CSD will provide for flyers to be given to elementary schools and Sally Bergen is working on other advertising and handing out flyers. Barbara said there is a feature on Facebook that we could use to post ads to our "friends" (\$5 each time) and she will pursue this. Dennis Buscher said he would donate up to \$50 to use this feature. It was suggested that we look for some large orange fencing to put around the front of the Reese school to ensure no one trespasses or gets too close (maybe CSD has some). Diane said the Spirit Halloween store is open and has a large assortment of costumes and decorations. Jeanette expects decorating to begin this weekend.
