**Appointments:** Appointments were recommended by President Ken Miller for the year 2021.Louis Silveira as Webmaster, Newsletter Editor and Archivist; David Chalmers as Facilities Manager and Barbara Claire as Assistant Treasurer. Roberta Tanner was confirmed by the Rhoads School Board as Rhoads School Director. Jeanette Lawson made a motion to approve the President's appointments with a second by Rosemarie Miller. Motion passed with 6 votes. A question was brought up to check old minutes and By-Laws to see if the Assistant Treasurer can vote in Board meetings when the Treasurer is absent.

**Treasurer's Report:** Jeanette Lawson gave a report of the Museum accounts. The General Budget is \$253,053 including an Operating Budget of \$213, 207.77, Rhoads school of \$11, 984.20, Museum Store of \$4, 050.61 and Real Estate of \$23, 376.71. She requested approval of a \$5000 kitchen plan expense to Pressey. Motion made by Roberta Tanner to approve the expense with a second by David Chalmers. Motion passed with 6 votes.
