

History Report

I have asked our new historian, Tom Russell, to give me information on the oldest house in Elk Grove. Is it the Mrs. McFarland's (Daddy Howe's bakery) which is owned by members Sarah & John Johnson at 9612 Kent St.? Or is it the Harvey Kerr home on Walnut Ave owned by new member Wayne Bailey? Sarah's house apparently was built in 1869 and a sign in front of the Bailey house says 1859. G. H. Kerr arrived in the area in the mid 1850's and according to the 1860 census his house was worth \$700. After 20 years of ownership he deeded it to his stepson Ernest W. Springsted. The

A bill for 844.45 dollars for the Luttig Garden and a bill for 43.34 dollars for rose food were approved by the Board. A donation of 1,000 dollars was presented to the Board from the Luttig family.

Lucille Christesen reports that the next General Meeting will be held at Logan's Road House and Paula Maita will speak.

The Board discusses Speakers and locations for next years' meetings The Red Door in Old Elk Grove is donating a great new display case. Sarah Johnson says the Old Town is welcoming lots of new businesses and the Old Town redevelopment project will soon go to the planning commission.

Old Business

Dennis reports on the progress of the granite walkway in the Luttig Garden. The Board is grateful to the help received by the Elk Grove gardening clubs. The Board discussed restoration on the Foulks Ranch House and Dennis Buscher shared a letter he received from Lucinda Woodward. Nalan Ludwig and Jon Colton did a great job on Nalan's Eagle Scout project to redo the back patio to make it more ADA compatible. Jeannette Lawson reported many tickets have been sold for the Christmas Gala and that Decorators are scheduled to set up in October and December. The Board discusses scholarships for Rhoads School and 500 dollars for scholarships are approved by a unanimous vote by the Board.

New Business

Officers for the new Board in 2010 were discussed as several Board members have resigned. Brookelea Lutton as agreed to edit the newsletter, Tom Russell as Historian and Carmel Silva as Archivist. The Board unanimously approves buying a printer for the Museum. The Board discusses renovation plans for the two buildings on our lot.
