Meeting called to order at 3:04 PM by President Bret Bartholomew.

Agenda: A motion to approve the Agenda made by Bret Bartholomew with a second by Jeanette Lawson. Motion passed.

Rhoads School: Roberta reported that 15 classes have attended this year with 30 schools scheduled and 15 pending. Three additional classes requested scholarships. Roberta said the school was in need of slate boards. Roberta asked Eric about the porch. Eric has discussed with CSD the situation and said it may qualify as a safety issue.
